The Hon. John H. Roll award was created to honor Judge John Roll, a Chief Judge of the U.S. District Court of Arizona who was slain on January 8, 2011, during Rep. Gabrielle Giffords' ill-fated community outreach event. This award recognizes prosecutors who are dedicated to the criminal justice system. Dan Jurkowitz presented the first ever Hon. John H. Roll award to Barbara LaWall, who is the longest servicing County Attorney in Pima County history, and Christina Cabanillas, who is an expert in appellate work among other areas. Both award recipients are pillars in the legal community and spend time teaching and writing articles.
